

## **The Chicago Health Law Colloquium Fellowship Program: Spring 2015**

DePaul University College of Law and Loyola University Chicago School of Law are pleased to sponsor the first annual Chicago Health Law Colloquium. DePaul and Loyola will be bringing six nationally renowned health law scholars to Chicago to present and discuss their current research projects. Colloquium participants include health law faculty from Chicago-area schools, prominent health law practitioners, and a group of select students from DePaul and Loyola (“Chicago Health Law Colloquium Fellows”).

Students who are selected as Colloquium Fellows will enjoy a unique opportunity to participate in discussions with leading scholars and practitioners concerning cutting-edge topics in the areas of health law and bioethics. The Colloquium offers an opportunity to students to advance their understanding of health law in a forum that brings together all of Chicago’s educational and professional communities and that goes beyond traditional classroom-based learning. This is an exceptional opportunity for any student interested in obtaining a greater depth of knowledge concerning these areas or in participating in the development of health law scholarship.

In Spring 2015, the six scholars who will present and their topics, are:

To facilitate an engaged dialogue between students, other colloquium participants, and invited scholars, the health law Colloquium faculty from DePaul and Loyola<sup>1</sup> will lead Colloquium Fellows in discussion of background materials during the week prior to each formal presentation by an invited scholar. These “pre-presentation” sessions will provide Colloquium Fellows with the benefit of faculty guidance in developing expertise in new areas of the law, as well as developing skills necessary to actively critique scholarship.

The Health Law Colloquium Fellows will be selected based on academic ability, experience in health law and bioethics, and a demonstrated interest in exploring health law scholarship.

**Application Deadline:** November 10, 5:00 p.m.

**Eligible Students:** All J.D. students who have completed at least one full year at DePaul or Loyola by Fall 2014 are eligible; in other words, 2Ls, 3Ls, and 4Ls are eligible. Students pursuing LL.M. degrees are also eligible.

**Number of Fellowships:** Up to 8 Fellows will be chosen from each participating law school.

**Fellowship Requirements:** Fellows are expected to attend and be fully prepared for each of the Colloquium sessions as well as the pre-presentation sessions. Participation at these sessions is mandatory. Fellows will receive one hour of ungraded (Pass/Fail) credit. All scholar presentations will take place on Wednesdays from 4 p.m.- 5:15 p.m., with sessions alternating between DePaul and Loyola. The dates of scholarly presentations are listed above. Pre-presentation sessions will take place from 4 p.m.- 5:15 p.m. on the Wednesday of the week preceding each presentation (note that sometimes a break week will intervene). Thus, these sessions will take place on Jan. 21, Feb. 4, Feb. 18, March 4, April 1, and April 15. These sessions will occur concurrently at both DePaul and Loyola, with the sessions being connected by the use of video-conference facilities.

**Application Components:**

- (1) Application **cover sheet** (see attached)
- (2) **Law school transcript** (unofficial copy acceptable)
- (3) Current **resume**
- (4) **Fellowship interest essay** (no longer than two pages double-spaced, 12 size font) responding to the question: What is the most important issue facing health law in the 21st century and why?

**Application Process:** All applications will be reviewed by Professors and Epstein and Kinney. The Spring 2015 Chicago Health Law Colloquium Fellows will be selected as soon as practically possible and ideally prior to the beginning of Spring 2015 registration.
